Advanced vehicle-inspection technology from Perceptics boosts Orange County, Fla., Corrections Department ability to deter contraband and other prohibited activities

Inspection capability far greater than at most local, state, and federal correctional facilities

Advanced new vehicle-inspection technology has increased the ability of the Orange County, Fla., Corrections Department to detect and deter the introduction of contraband into its 81-acre secured compound as well as to detect efforts to exit the facility with any unauthorized property or people.

The Corrections Department partnered with Perceptics, LLC, to incorporate a very high technology-based vehicle inspection solution that far surpasses the inspection capability used in the past, including what is currently being used in most other correctional facilities around the nation, even surpassing the capabilities of the federal prison system. "We are very excited to have this level of inspection technology in the Orange County Jail and appreciate the support of the Orange County Board of Commissioners in helping us achieve the goal of being on the cutting-edge of technology," said Kim Lanham, project manager of construction at the Orange County Jail. "This and other technologies afforded us in the construction of our new facility reflect the deep commitment to law and order our County Commission has for the citizens of Orange County."

The new technology from Perceptics, which is based in Knoxville, Tenn., uses a very high-resolution image of the undercarriage of a vehicle to be compared side-by-side either with a previous image taken of the same vehicle or of a like vehicle. Any alterations can be detected and examined more closely. All vehicle images are stored in a database for further inspection and can be shared with other law enforcement agencies via email.
